## LETTER OF INFORMATION IN ACCORDANCE WITH THE LEGISLATIVE DECREE 196 OF 30/6/2003

"Code in relation to the protection of the personal data"

We inform you that according to art. 13 of Legislative Decree No. 196/2003, the personal information you provide could be subject to processing, in compliance with the above mentioned decree and with the privacy obligations our Company's activity is inspired to.

The processing of private data consists in any operation concerning the collection, recording, organization, storage, consulting, development, modification, selection, retrieval, comparison, use, interconnection, blocking, communication, diffusion, cancellation and destruction of data or the combination of two or more operations.

These data will be processed within the scope of the usual activity of our Company to achieve the objectives related to the management of the contractual relationship (already established or being established), with particular reference to: acquisition of information, conclusion of contacts, compilation of data, editing of statistics, keeping customers and / or suppliers accounts, billing, credit management, market research, fulfilment of commercial, administrative and taxation obligations and for everything arising directly or indirectly from the relationship with the writer.

The processing of personal data will take place by means of suitable tools to ensure the security and privacy. The processing can be made both with paper and computer means.

In compliance with the law, your personal data may be subject to communication to different stake-holders - such as: legal, tax or Company consulting offices, credit management Company, Banks and / or Credit Agencies, public Authorities or Governments and will not be spread out.

Please be also advised that in relation to the above processing, you can exercise the rights according to Art. 7 of Legislative Decree 196/2003 which, among other things, entitles you to obtain an indication of the source of the data, the updating, rectification, integration, cancellation, transformation under anonymous form, blocking of the data, as well as to object to their processing, writing to the Data Controller mentioned below.

We finally point out that the provision by you of the data in question is not compulsory: any possible refusal to provide your data will involve the non-establishment of any relationship or will cause the discontinuance of the same.
